#### **Additional requirements relating to the Award of Qualification**

In order to qualify for the MSc Audiology with Clinical Placement candidates must additionally undertake a 40-week clinical placement.

In order to qualify for the Postgraduate Diploma Audiology (with Clinical Placement), students must pass all taught modules and the Placement module.
